ISSUE AND ALLOTMENT OF SHARES PURSUANT TO THE EXERCISE OF 293,000 WARRANTS

The Board of Directors of Riverstone Holdings Limited (the “**Company**”) is pleased to announce the issue and allotment of an aggregate of 293,000 ordinary shares in the capital of the Company at the exercise price of S\$0.31 each, pursuant to the exercise of the 293,000 warrants. These new shares will be listed and quoted on the Singapore Exchange Securities Trading Limited on 19 September 2012.

The new shares issued shall rank *pari passu* in all respects with the existing shares of the Company.
