Riverstone wins two bronze accolades at the Singapore Corporate Awards 2016

- Second runner-up for Best Managed Board and Best Investor Relations, Mid-cap category

SINGAPORE - 19 July 2016 – Mainboard-listed Riverstone Holdings Limited (“Riverstone” or “the Group”) 立合斯顿有限公司, a leading manufacturer of specialised cleanroom and healthcare gloves, is pleased to announce that the company has won Bronze in two of the five categories at the Singapore Corporate Awards (“SCA”) 2016.

Co-organised by the Institute of Singapore Chartered Accountants, Singapore Institute of Directors and Business Times, the SCA aims to drive awareness for the importance of strong corporate disclosure and corporate governance standards amongst companies listed in Singapore. At the gala dinner held at Resorts World Convention Centre and attended by Guest of Honour and Minister for Health Mr Gan Kim Yong, Riverstone received two bronze awards for the Best Managed Board and Best Investor Relations (“IR”) for companies in the Mid-Cap category (between S\$300 million to S\$1 billion in market capitalisation).

The Best Managed Board Award focuses on the composition of a Company’s Board of Directors, including the degree of diversity, accountability and alignment of interest. Separately, the Best IR Award recognises companies that adopt strong corporate governance and processes within its IR function, particularly responsiveness to queries, overall transparency and quality of information provided to shareholders. While this is the first time Riverstone received any awards at the SCA, it marks the Group’s second accolade for IR in 2016. Earlier this year on 23 March, Riverstone clinched the “Gold” prize at the [PR Awards 2016](#) for “Best IR Campaign”.
